<u>Chapter-3</u> CONDITIONS OF CONTRACT

1 The company quoting for fabrication /body building should be ISO Certified.

- 2 It should be specifically stated whether Sales Tax/VAT etc. are payable in addition to the price quoted, otherwise, the price quoted will be assumed to be all-inclusive and no separate tax or charges will be paid in the event of the offer being accepted.
